**Tuition fees:** The minimum and maximum fees are set by Skills Victoria. Each individuals final tuition fee rate is known when the nominal hours of study for their qualification are established. This is then multiplied by an hourly rate which is set for each qualification level by Skills Victoria. Tuition fees are invoiced for the amount of hours you are expected to complete in the calendar year. Therefore if your training is over more than one calendar year then you will receive two (2) invoices.

**JSA Fee Waivers:** Students enrolling who are also a registered with a Job Services Australia Provider should enquire about a fee waiver.
